Beale Trucking Ltd Privacy Statement

At Beale Trucking Ltd we recognise the importance of privacy protection. We have created this Privacy Statement to demonstrate our commitment to you, your privacy and to secure and trustworthy Internet commerce.

Types of Personal Information we collect

Generally, the only personal information we collect is contact details of representatives of:

customers, prospective customers, partners, and other individuals interested in receiving information from Beale Trucking Ltd.

This includes details such as their names, addresses, telephone numbers and email addresses. We also record information concerning transactions that individuals make or wish to make with Beale Trucking Ltd and as well as information concerning customer preferences and satisfaction with Beale Trucking Ltd's products and services.

Beale Trucking Ltd's Compliance Commitment

Generally, Beale Trucking Ltd will only collect personal information when necessary to provide a specific service or function. This includes Beale Trucking Ltd product and event information and software upgrade information.

Where practicable, when this personal information is collected it is done so directly from the individual, either by phone, over the Internet or in person. We may also collect personal information indirectly such as where one customer representative gives us details of another customer representative.

Collection of personal information

Beale Trucking Ltd will take reasonable steps to ensure that the individual is aware of:

- Beale Trucking Ltd's identity and how to contact us,
- their ability to gain access to their personal information,
- the purposes for which the information is collected,
- the organisations (or the types of organisations) to which Beale Trucking Ltd usually discloses information of that kind,
- any law that requires the particular information to be collected, and
- the main consequences (if any) for the individual if all or part of the information is not provided.

If Beale Trucking Ltd collects personal information about an individual from someone else, Beale Trucking Ltd will take reasonable steps to ensure that the individual is or has been made aware of the matters listed above.

Use and Disclosure

Generally Beale Trucking Ltd will only use and disclose personal information for the primary purpose for which it was collected. For example, personal information may be used to provide a specific service or function to individuals, to process requests and transactions, and to communicate marketing offers and information to individuals.

This may include providing personal information to external organisations or to our related companies where they are assisting us to provide a service or function. Where we do provide third parties with personal information, we have measures in place to ensure they do not use the personal information for any purpose other than providing the relevant service or function.

Beale Trucking Ltd will only use or disclose personal information about an individual for a purpose other than the primary purpose (the secondary purpose) of collection if:

- The secondary purpose is related to the primary purpose of collection; and
- The individual would reasonably expect Beale Trucking Ltd to use or disclose the information for the secondary purpose; or
- The individual has consented to the use or disclosure; or

If the information is not sensitive information and the use of the information is for the secondary purpose of direct marketing: it is impracticable for Beale Trucking Ltd to seek the individual's consent before that particular use; and

- Beale Trucking Ltd will not charge the individual for requesting to not receive direct marketing communications; and
- the individual has not made a request to Beale Trucking Ltd not to receive direct marketing communications; and
- in each direct marketing communication with the individual, Beale Trucking Ltd directly advises the individual, or prominently displays a notice, that he or she may express their desire not to receive any further direct marketing communications; and
- each written direct marketing communication by Beale Trucking Ltd with the individual (up
 to and including the communication that involves the use) sets out Beale Trucking Ltd's
 business address and telephone number and, if the communication with the individual is
 made by fax, telex or other electronic means, a number or address at which Beale Trucking
 Ltd can be directly contacted electronically; or
- Beale Trucking Ltd has reason to suspect that unlawful activity has been, is being or may be engaged in, and uses or discloses the personal information as a necessary part of its investigation of the matter or in reporting its concerns to relevant persons or authorities; or
- the use or disclosure is required or authorised by or under law; or
- Beale Trucking Ltd reasonably believes that the use or disclosure is reasonably necessary for one or more of the following by or on behalf of an enforcement body:
- the prevention, detection, investigation, prosecution or punishment of criminal offences, breaches of a law imposing a penalty or sanction or breaches of a prescribed law;
- the enforcement of laws relating to the confiscation of the proceeds of crime; the protection of the public revenue;

- the prevention, detection, investigation or remedying of seriously improper conduct or prescribed conduct;
- the preparation for, or conduct of, proceedings before any court or tribunal, or implementation of the orders of a court or tribunal.

Data quality

Beale Trucking Ltd will take reasonable steps to ensure that the personal information we collect, use or disclose is accurate, complete and up-to-date. If you believe that the information held is inaccurate please do not hesitate to contact the Privacy Officer below.

Data Security

Beale Trucking Ltd will take reasonable steps to protect the personal information we hold from misuse and loss and from unauthorised access, modification or disclosure. Beale Trucking Ltd stores personal information in various secure electronic storage facilities and paper-based files. Beale Trucking Ltd will also take reasonable steps to destroy or permanently de-identify personal information if it is no longer needed for any purpose for which the information may be used or disclosed.

Openness

Beale Trucking Ltd policy on our management of personal information is set out in this document, as may be amended by Beale Trucking Ltd from time to time. Access and Correction

If Beale Trucking Ltd holds personal information about an individual, we will provide the individual with access to the information on request by the individual, except to the extent that:

- in the case of personal information other than health information-providing access would pose a serious and imminent threat to the life or health of any individual; or
- providing access would have an unreasonable impact upon the privacy of other individuals;
 or
- the request for access is frivolous or vexatious; or
- the information relates to existing or anticipated legal proceedings between the organisation and the individual, and the information would not be accessible by the process of discovery in those proceedings; or
- providing access would reveal the intentions of Beale Trucking Ltd in relation to negotiations with the individual in such a way as to prejudice those negotiations; or
- providing access would be unlawful; or
- denying access is required or authorised by or under law; or
- providing access would be likely to prejudice
- an investigation of possible unlawful activity; or
- the prevention, detection, investigation, prosecution or punishment of criminal offences, breaches of a law imposing a penalty or sanction or breaches of a prescribed law; or
- the enforcement of laws relating to the confiscation of the proceeds of crime; or the protection of the public revenue; or

- the prevention, detection, investigation or remedying of seriously improper conduct or prescribed conduct; or
- the preparation for, or conduct of, proceedings before any court or tribunal, or implementation of its orders; by or on behalf of an enforcement body; or
- an enforcement body performing a lawful security function asks Beale Trucking Ltd not to
 provide access to the information on the basis that providing access would be likely to cause
 damage to the security of the country.

However, where providing access would reveal evaluative information generated within Beale Trucking Ltd in connection with a commercially sensitive decision making process, Beale Trucking Ltd may give the individual an explanation for the commercially sensitive decision rather than direct access to the information.

If Beale Trucking Ltd is not required to provide the individual with access to the information because of one or more of the above paragraphs Beale Trucking Ltd will, if reasonable, consider whether the use of mutually agreed intermediaries would allow sufficient access to meet the needs of both parties.

If Beale Trucking Ltd charges for providing access to personal information, those charges:

- will not be excessive; and
- will not apply to lodging a request for access.

If Beale Trucking Ltd holds personal information about an individual and the individual is able to establish that the information is not accurate, complete and up-to-date, Beale Trucking Ltd will take reasonable steps to correct the information so that it is accurate, complete and up-to-date.

If the individual and Beale Trucking Ltd disagree about whether the information is accurate, complete and up-to-date, and the individual asks Beale Trucking Ltd to associate with the information a statement claiming that the information is not accurate, complete or up-to-date, Beale Trucking Ltd will reasonable steps to do so.

Beale Trucking Ltd is obliged to provide reasons for denial or refusal of access to correct personal information. If you would like to access any personal information held by Beale Trucking Ltd about you, please do not hesitate to contact the Privacy Officer below.

<u>Identifiers</u>

Beale Trucking Ltd does not use identifiers such as Tax File Numbers to identify individuals.

Anonymity

Where lawful and practicable, Beale Trucking Ltd will provide individuals with the option of not identifying themselves when providing personal information.

Transborder Data Flows

Beale Trucking Ltd may transfer personal information about an individual to someone (other than Beale Trucking Ltd or the individual) who is in a foreign country only if:

- Beale Trucking Ltd reasonably believes that the recipient of the information is subject to a law, binding scheme or contract which effectively upholds principles for fair handling of the information; or
- the individual consents to the transfer; or

- the transfer is necessary for the performance of a contract between the individual and Beale Trucking Ltd, or for the implementation of pre-contractual measures taken in response to the individual's request; or
- the transfer is necessary for the conclusion or performance of a contract concluded in the interest of the individual between Beale Trucking Ltd and a third party; or all of the following apply:
 - o the transfer is for the benefit of the individual;
 - o it is impracticable to obtain the consent of the individual to that transfer;
 - if it were practicable to obtain such consent, the individual would be likely to give it;
 or

Beale Trucking Ltd has taken reasonable steps to ensure that the information that it has transferred will not be held, used or disclosed by the recipient of the information inconsistently with this Privacy Statement.

Sensitive Information

Generally Beale Trucking Ltd does not collect sensitive information. In the event Beale Trucking Ltd does wish to collect sensitive information however, we will not do so unless:

- o the individual has consented; or
- o the collection is required by law; or
- the collection is necessary to prevent or lessen a serious and imminent threat to the life or health of any individual, where the individual whom the information concerns
- o is physically or legally incapable of giving consent to the collection;
- o physically cannot communicate consent to the collection; or
- the collection is necessary for the establishment, exercise or defence of a legal or equitable claim.

Removal from Beale Trucking Ltd Mailing Lists

Should you decide that you no longer wish to receive promotional and marketing material from Beale Trucking Ltd, please advise as directed on the material you have been sent or via email, fax or letter being sure to include your name, address and contact details.

Complaints Management

Individuals are to direct all complaints to Beale Trucking Ltd's privacy officer.

To be removed from a distribution list:

Beale Trucking Ltd requires this request to be advised in writing via email, letter or fax.

Beale Trucking Ltd will notify all departments within Beale Trucking Ltd to remove the individual from distribution lists.

Beale Trucking Ltd will advise the individual in writing that this request has been actioned.

To access information held by Beale Trucking Ltd:

The individual is to advise Beale Trucking Ltd in writing via email, fax or letter. (See below, Access to Personal Information held by Beale Trucking Ltd)

Access to Personal Information held by Beale Trucking Ltd

When an individual requests access to their personal information, Beale Trucking Ltd will:

- take all reasonable endeavors to take action within 30 days of receipt of notification from the individual;
- require individuals to provide written notification to access personal information held by Beale Trucking Ltd;
- evaluate the request for access to determine motivation for requesting access: e.g. is the request frivolous or vexatious?
- o For a valid request, Beale Trucking Ltd's privacy officer will:
- o inform all relevant departments that this individual has requested to access the information held;
- o consolidate all of the information;
- o discuss with the individual how they would like to view this information:
- If personally, Beale Trucking Ltd's privacy officer and the individual will arrange a meeting time and place;
- o If via letter / photocopies, Beale Trucking Ltd's privacy officer will prepare and send these to the individual.

Protection and use of information collected on-line

Use and purpose of collected personal data

On our Web sites we only collect information relating to you with your permission. You may choose to reveal information to us if, for example, you register or complete a survey. Companies in the Beale Trucking Ltd group may use the information internationally in connection with processing your inquiries and orders or to help improve our products and services. We would only share such information with third parties outside the Beale Trucking Ltd group with your express permission or as required by law. It is used solely for the purposes described below.

Online security

Beale Trucking Ltd supports secure online shopping using secure server technology, because we want your shopping experience to be simple and safe. There are state-of-the art security arrangements and facilities on Beale Trucking Ltd sites to prevent security abuse. The secure server technology used on Beale Trucking Ltd Store encrypts your personal financial information before it is

transmitted over the Internet. This technology works best when the store site is viewed using a browser that supports secure server technology.

Privacy across the entire Beale Trucking Ltd network

As a global company, Beale Trucking Ltd operates a number of Web sites around the world. Any information that you submit to one of our sites in any one country or language may be sent electronically to a server for one of these sites in another country. As such, the information may be used, stored, or processed outside the country where it was recorded. We safeguard your privacy interests around the world by ensuring that the Beale Trucking Ltd site adheres to our policies described in this statement. We bind our employees to observe your privacy and confidentiality rights.

Consent

By using our Web sites, you consent to the collection and use of the information as described here. If we decide to make changes to this privacy statement, we will post the changes on this page so that you will always know what information we collect, and how we use it.

What information do we collect on-line and why?

IP addresses

We may use your IP address to help diagnose problems, to administer our Web site, or to gather general demographic information.

Cookies

We use cookies to make your use of our online offering more enjoyable and to deliver personalised content. Cookies help us give you information that interests you, they save you having to reenter your password every time you visit our site, and help to keep track of your shopping cart. Cookies also allow us to better analyse our site traffic patterns so that we can improve our Web offering. We do not follow your browsing path outside of the Beale Trucking Ltd site; Web partners that serve ads onto our Web site may also use their own cookies.

User registration

You may choose to fill out a registration form on our Web site with contact information. This information is used to send you requested information or products, to contact you with other product information, news, or promotions, and to learn more about our Web visitors.

E-mail addresses

If you give us your e-mail address, we may communicate with you via e-mail. However, we will not share your e-mail address with others outside the Beale Trucking Ltd group of companies without your consent. You can choose not to receive e-mails at any time - for more details, read the Choice/Opt-out section below. Depending how your e-mail application is set up, information about you may be transmitted automatically when you send e-mail to Beale Trucking Ltd.

Registration for third-party services at Beale Trucking Ltd

At Beale Trucking Ltd you can register for third party services. Those services are available through Beale Trucking Ltd, but are provided by a third party, which is typically not affiliated with Beale Trucking Ltd. When you sign up for one of these services, it may be necessary to transfer some of your Beale Trucking Ltd.com registration information to this service provider. Also, if the service you chose requires your e-mail address to fulfill this service, we will also give your e-mail address to the service provider. This means we will pass your e-mail address to a service provider only in the event that you specifically asked for this service and the service cannot be provided without your e-mail address. For privacy practices and opt-out procedures of those service providers, refer to the individual privacy policy of the respective service provider.

"Send this to a friend" service

You can choose to forward information, a Web page, or link to someone else using our "Send this to a friend" e-mail service. In order to do that, you provide us with your e-mail address, as well as that of the recipient. This information is used only in the case of transmission errors and, of course, to let the recipient know who sent the e-mail. The information is not used for any other purpose.

Shopping
